The financial agreement is determined between the patient and the financial department based upon each patient's needs. Moffitt does not turn patients away for treatment.

All clients go to the financial counseling office and they apply for Medicaid and/or Charity Care. For all approved clients, treatment is covered at no cost.

Eligibility Requirements:

Clients must reside in East Polk County (Winter Haven, Bartow, Lake Wales and Haines City) to qualify for charity care. If the client resides outside of the region, they are referred to a closer treatment facility and will not be seen at the Cassidy Center.

THE BREAST AND CERVICAL CANCER EARLY DETECTION PROGRAM

This program is managed by the Florida Department of Health in Hillsborough County. It covers mammogram screenings at no-cost for women 50 to 64 years of age. They must be uninsured or under-insured, and they must meet income requirements.
